## **GROUND FLOOR**

Communal entrance with post boxes and stairs to the upper floors.

#### HALL

An L-shaped hall with entry phone and large cloaks cupboard.

#### SITTING ROOM

20' 2 max" x 11' 7" (6.15m x 3.53m) A spacious dual aspect sitting room having windows to both the front and rear elevation. There are two radiators, a telephone point and a television aerial point.

## **KITCHEN**

10' 9" x 6' 9" (3.28m x 2.06m) Fitted with a range of wood effect base and wall units having complementary work surfaces, tiled splash backs and a stainless steel sink unit with mixer tap. Appliances comprise an electric oven and hob, a fridge freezer and washing machine. Telephone point, tiled effect flooring and window to the front elevation.

#### **BEDROOM ONE**
