## GROUND FLOOR

### SITTING ROOM

14' 9" x 14' 5" (4.5m x 4.39m) Having a large window to the front elevation, two radiators, television and telephone points, useful coat hooks and stairs leading to the first floor.

### DINING KITCHEN

14' 4" x 10' 3" (4.37m x 3.12m) The light and bright kitchen is fitted with a range of base and wall units having complementary work surfaces and sink unit. Appliances comprise an integrated electric oven and microwave, ceramic five ring hob with cooker hood, fridge freezer and dishwasher. There is also plumbing for a washing machine. Tiled floor, recessed spotlights, two windows and a door leading out to an enclosed rear yard.

## FIRST FLOOR

### BEDROOM

14' 1" x 10' 2" (4.29m x 3.1m) Having two mirrored recessed wardrobes and an additional walk in wardrobe with curtain frontage, radiator and a window to the front elevation.

### BATHROOM

10' 10" x 9' 4" (3.3m x 2.84m) Fitted with a modern white suite comprising a panelled bath, separate shower enclosure, vanity unit with oval wash basin and low suite w.c. There is also a heated towel rail, extractor fan and light with shaver point. Tiled floor and a window to the rear elevation.





## SECOND FLOOR

### ATTIC ROOM / OFFICE

15' 10 to eaves" x 14' 06" (4.83m x 4.42m) Ideally suited as a home office or snug the attic room has under eaves storage, radiator and 2 skylights with blinds.

### OUTSIDE

There is an enclosed walled yard with outhouse and a gate to the rear.

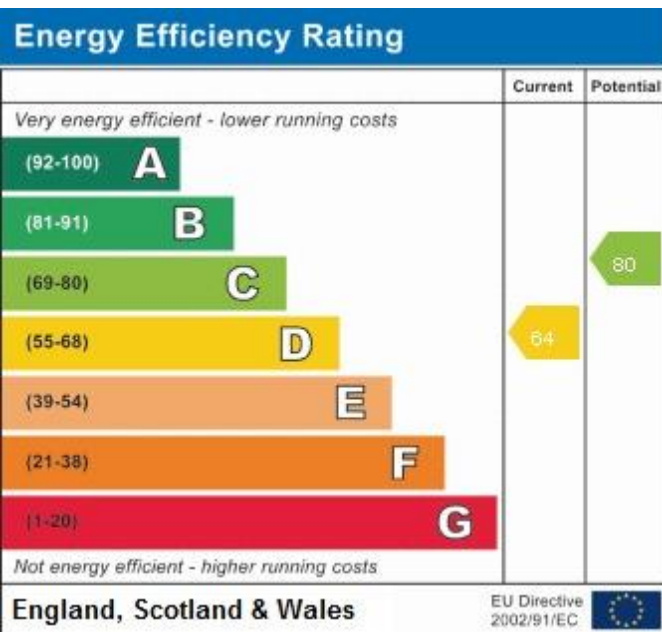

If your application is unsuccessful following referencing you will forfeit the holding fee.
2. The first month's rent is payable in advance prior to the commencement of the tenancy.
