### **PARKING**

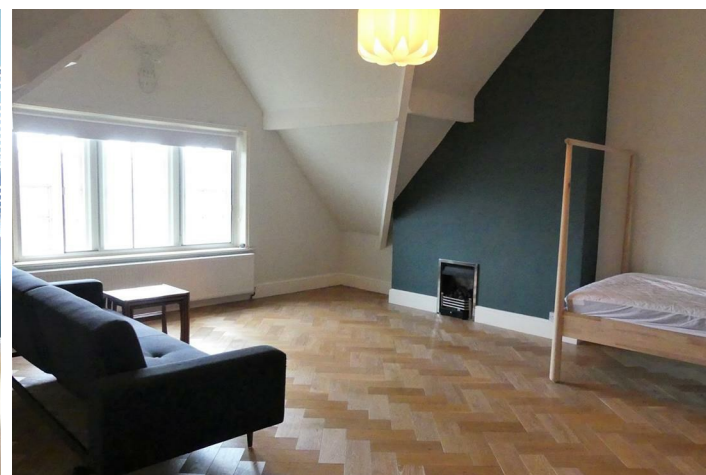
Off street parking is available on a first come first served basis.

## PAYMENTS

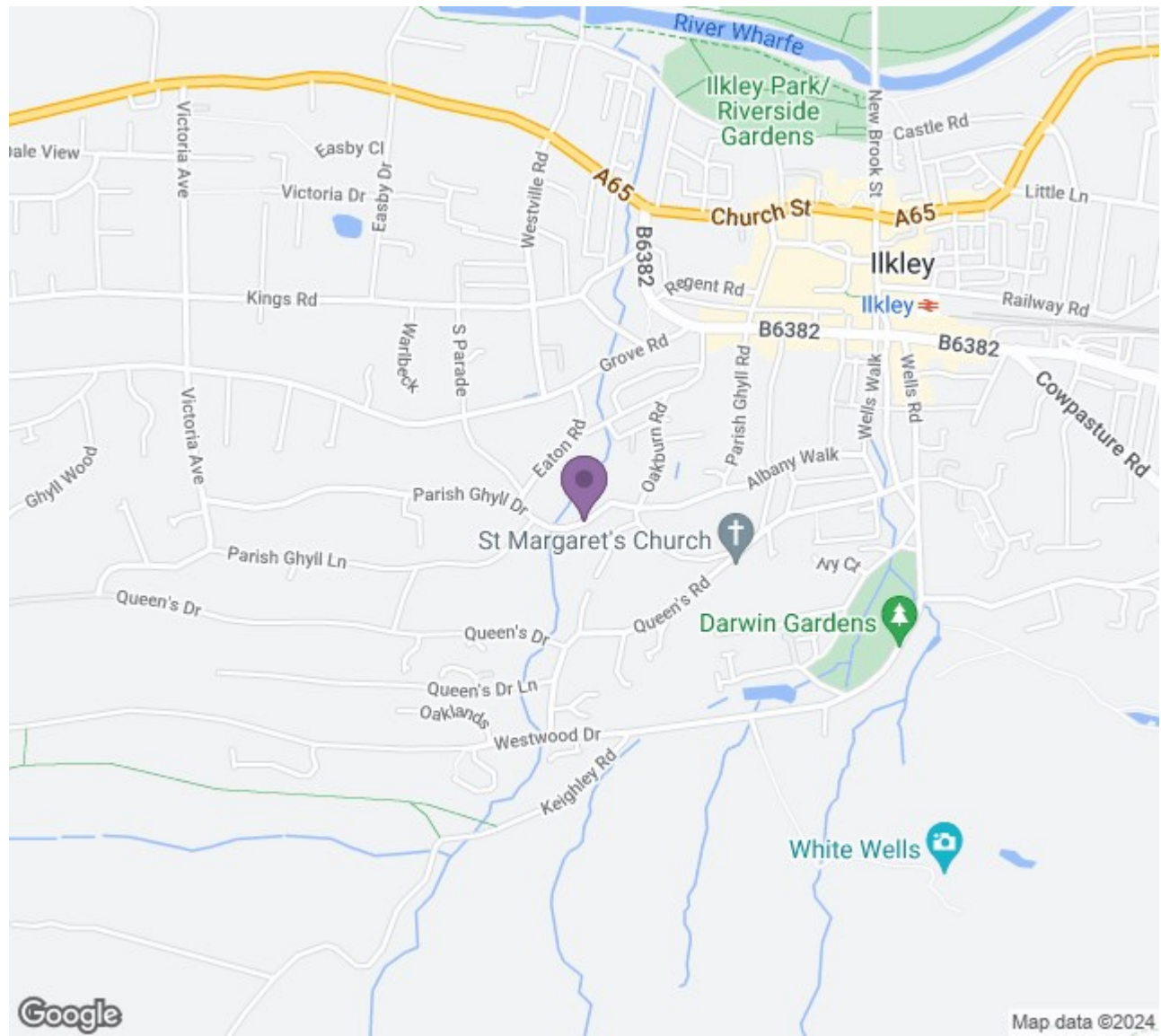

2. The first month's rent is payable in advance prior to the commencement of the tenancy.
